for the use of the MTDC Industry 4.0 TechWeek. These terms and conditions outline the rules and regulations

By signing up for MTDC Industry 4.0 TechWeek we assume you accept these terms and conditions in full. Do not continue to use MTDC Industry 4.0 TechWeek if you do not accept all of the terms and conditions stated on this page.

User Rules and Regulation
