

PRIVACY POLICY

This privacy policy will explain how Malaysian Technology Development Corporation uses the personal data we collect from you when you use MTDC Industry 4.0 TechWeek.

What data do we collect?

This section explains the personal information that may be collected when using our services, and the other personal data we may receive from other sources.

In this Privacy Policy, the term “personal information” refers to the types of information we may collect and use, which includes:

- Contact details, such as your name, e-mail address, postal address and telephone number;
- Educational, nationality and professional background information;
- Usernames and passwords;
- Payment information, such as a credit or debit card number, bank details and billing address;
- Comments, feedback, posts and other content you submit;
- Identity verifying information such as passport details to comply with our legal obligations in certain countries and to provide Visa invitation letters where requested;
- Interests and communication preferences, including marketing permissions where appropriate; and
- Location information (e.g. through mobile apps).

How do we collect your data?

You directly provide how Malaysian Technology Development Corporation with most of the data we collect. We collect data and process data when you:

- Register online for our events.
- Voluntarily complete a customer survey or provide feedback in any of our events or via email.
- Use or view MTDC Industry 4.0 TechWeek via your browser’s cookies.
- We may also receive your data indirectly from the following sources:
- Information provided by the Organizer to facilitate the registration process.

How will we use your data?

We may use the information we obtain about you to:

- Create, manage and maintain your account.
- Provide you with services that you request.
- Manage your participation in events hosted, where you have signed up for such events and promotions.
- Maintain a record of the events in which you participate, including chat and webinar history and download activity.
- Enable you to interact with other event participants.
- Provide administrative notices or communications.
- Respond to your questions and comments and provide customer support.
- Operate, evaluate and improve our business and the products and services we offer.
- Analyze and enhance our marketing communications and strategies (including by identifying when emails we have sent to you have been received and read).

- Analyze trends and statistics regarding visitors', mobile applications and social media assets, and the jobs viewed or applied to.
- Notify you from time to time about relevant products and services operated by MTDC Industry 4.0 TechWeek.
- Enforce our MTDC Industry 4.0 TechWeek's Terms of Service.
- Comply with applicable legal requirements and industry standards and our policies.

We also use non-personally identifiable information and certain technical information about your computer and your access (including your internet protocol address) in order to operate, maintain and manage MTDC Industry 4.0 TechWeek. We collect this information by automated means, such as cookies and web beacons, as described in more detail below.

We may collect, compile, store, publish, promote, report, share or otherwise disclose or use any and all Aggregated Information, however, unless otherwise disclosed in this policy, we will not sell or otherwise transfer or disclose your Personal Information to a third party without your consent. If we seek to use the information we obtain about you in other ways, we will provide specific notice and request your consent at the time of collection.

How do we store your data?

MTDC Industry 4.0 TechWeek maintains administrative, technical and physical safeguards designed to assist us in protecting the Personal Information we collect against accidental, unlawful or unauthorized destruction, loss, alteration, access, disclosure or use.

Please note that no electronic transmission of information can be entirely secure. We cannot guarantee that the security measures we have in place to safeguard Personal Information will never be defeated or fail, or that those measures will always be sufficient or effective. Therefore, although we are committed to protecting your privacy, we do not promise, and you should not expect, that your Personal Information will always remain private. As a user of MTDC Industry 4.0 TechWeek, you understand and agree that you assume all responsibility and risk for your use of MTDC Industry 4.0 TechWeek, the internet generally, and the documents you post or access and for your conduct on and off MTDC Industry 4.0 TechWeek.

To further protect yourself, you should safeguard your MTDC Industry 4.0 TechWeek password and not share that information with anyone. You should also log off from and close your browser window when you have finished your visit to MTDC Industry 4.0 TechWeek. Please note that we will never ask for your MTDC Industry 4.0 TechWeek account password via email.

What are your data protection rights?

We would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Malaysian Technology Development Corporation for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that we correct any information you believe is inaccurate. You also have the right to request us to complete the information you believe is incomplete.

The right to erasure – You have the right to request that we erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that we restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Malaysian Technology Development Corporation’s processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.

If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact us.

What types of cookies do we use?

There are a number of different types of cookies, however, MTDC Industry 4.0 TechWeek uses:

Essential Cookies or Strictly Necessary Cookies: These cookies are essential to the Service in order for you to move around the Service and to use its features. Without these cookies, certain features could not function. No information about your browsing habits is gathered by these cookies.

Functional Cookies: These cookies remember how you prefer to use MTDC Industry 4.0 TechWeek and enable us to improve the way it works. We can remember your settings and help provide you with ads. Functional Cookies are persistent cookies that MTDC Industry 4.0 TechWeek remembers when your computer or device comes back to MTDC Industry 4.0 TechWeek.

Analytics Cookies: Analytics Cookies allow us to improve our services by collecting information about your use MTDC Industry 4.0 TechWeek. We use these cookies to help improve how the website works. For example, Analytics Cookies show us statistics, which are the most frequently visited pages, help us record any difficulties you have, and show us whether our advertising is effective or not. We can’t identify you personally through the use of these cookies, but third parties who provide these cookies may be able to.

Geo-Location Information: Some of the information we collect from a device, for example IP address, can sometimes be used to approximate a device’s location.

How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of the MTDC Industry 4.0 TechWeek platform features may not function as a result.
